It Pays to Get Healthy

Rewards for Wellness 2024-2025

This unique State-sponsored program makes it easier to get the care you need—and rewards you for doing it.

As a State employee, you can earn up to \$500 in wellness credits by participating in a variety of activities of your choosing. The credits are automatically applied to your bi-weekly medical plan premium (your co-share) on ten select pay days in 2025.

Annual Preventive Exam Incentive

Receive an annual preventive exam in 2024 and earn \$250 in credit toward your co-shares. You can earn an additional \$250 in credit toward your co-shares if your spouse or domestic partner receives an annual preventive exam in 2024.2 The following preventive exams qualify for the incentive: annual physical exam, annual gynecological exam, or prenatal obstetric exam. Blue Cross & Blue Shield of Rhode Island (BCBSRI) will automatically track your participation in this program through medical claims activity.



Rewards for Wellness Activities

We're offering even more ways you can get and stay healthy. Complete as many activities as you'd like. Please note, the maximum possible payout for 2024 activities is \$500 of co-share credit incentives, regardless of how many activities you complete.

Employee Assistance Program (EAP)

Your emotional health matters. Each month, the State's EAP will feature a brief video and quiz on different well-being topics. Earn \$25 in co-share credits/month by watching the videos and completing the quizzes.

Wellbeats

Available through Virgin Pulse, Wellbeats includes 1,000+ online, on-demand fitness, nutrition, and mindfulness classes.

Wellness activities through Virgin Pulse

You can earn quarterly incentives based on your activity level. Virgin Pulse is available through your myBCBSRI account or by downloading the app via your favorite app store.

Virgin Pulse Health Check survey

Earn \$50 in co-share credits for answering simple questions that can help you get a better picture of your overall health.

Biometric screenings

Get screened for blood pressure, body mass index (BMI), total cholesterol, and blood glucose at an onsite health fair or your physician's office and earn \$100 in co-share credits. Download your unique form through Virgin Pulse if your screenings are done via your provider.

Annual dental cleaning/exam

Good oral hygiene is essential to good overall health. Get your annual exam and earn \$50 in co-share credits.

Step challenges

Sign up and participate and you'll earn \$25 in co-share credits for each challenge completed. Prizes will be awarded to the top three teams for each challenge. The grand prize winners will receive a Yeti® tumbler.

Preventive screenings

These tests can help detect problems in their early stages. Bone density is now an eligible screening, in addition to mammogram, pap smear, PSA screening, and colonoscopy. Earn \$50 in co-share credits for each applicable screening you receive.

Annual eye exam

You only get one set of eyes. Earn \$50 in co-share credits when you receive an exam in 2024.

Flu shot

Receive a flu shot at a state-sponsored flu shot clinic, your provider's office, or a local pharmacy and earn \$50 in co-share credits. If you receive your flu shot from somewhere other than a State flu shot clinic and you don't use your BCBSRI medical coverage or CVS pharmacy coverage, you must complete the Flu Shot Verification Form and submit it to BCBSRI to earn credit. The Flu Shot Verification Form is available at employeebenefits.ri.gov/employee-wellness/rewards-wellness-2024-2025.

New online registrations

Earn \$25 for each new registration with myBCBSRI, Virgin Pulse, and/or Doctors Online. The credits do not apply if you have already registered with a specific program.

 $^{^{1}}$ Participants can earn a maximum of \$500 in co-share credit incentives per year through the Rewards for Wellness program.

² Only active State of Rhode Island employees who are paying State medical co-share premium payments at the time of the incentive payout(s) are eligible to receive co-share credit incentives. To receive \$250 in credits for a spouse's annual preventive exam, the spouse must have been covered as a dependent on the employee's family plan both when they received a qualifying annual preventive exam and when the incentives are paid out. Credits will be delivered over five consecutive paydays in the second half of 2025. (Payout dates are listed on page 5.) State of Rhode Island Rewards for Wellness 2024–2025

To earn co-share credits, employees must complete activities between 1/1/2024 and 12/31/2024. Employees can earn a maximum total of \$500 in co-share credits, regardless of the number of activities completed.

Request your MaxBuzz through the Virgin Pulse app or online by using the code "FREEMAXBUZZ" where indicated. Your new fitness tracker will be shipped directly to your house.

The 2024–2025 Rewards for Wellness Program will not associate payout dates with specific activities. Instead, employees will be paid for the activity/activities they complete within each pay period. Receive personalized workout plans, track your progress, find new recipes, and more. Wellbeats is included with your medical coverage. You can receive a \$25 quarterly incentive for completing four Wellbeats classes per quarter or 80 total minutes of Wellbeats class time per quarter, plus earn Virgin Pulse³ wellness points for your activities:

Take active steps to help prevent type 2 diabetes

The State of Rhode Island Diabetes Prevention Program (DPP) is available in-person for State employees and eligible dependents age 18+ who meet specific health criteria. The State pays all associated program costs. There is no cost to the employee or eligible dependent to participate.

In-person DPP (facilitated by Lifespan and BCBSRI)

Led by a trained lifestyle coach, this program can help you establish and maintain healthy habits, which could help reduce your risk of developing type 2 diabetes.

- Classes are offered at Your Blue StoreSM
- Sessions are available Monday through Thursday after 4:30 p.m.
- Attend weekly one-hour sessions for at least 16 weeks (within a six-month period)
- Complete six months of weekly one-hour follow-up sessions
- Participate in group cooking lessons and receive healthy recipes to prepare at home
- Enjoy the support and camaraderie of peers with similar health goals
- Earn a one-time-only \$500 incentive upon completion of all program requirements*

Employees who register and complete 20 of 25 in-person sessions will qualify for a one-time-only taxable, \$500 wellness incentive reward.*

Eligible dependents age 18+ may participate in the program but will not receive the incentive.
